Being an index for a mining history serial, subject categories emphasize substances mined and the states and provinces where that mining occurred. Items are cross indexed by subject in the instances that it seems useful to do so. Within subject categories, articles appear alphabetically by title. The entire index may also be word searched using the computer's "Control F" function.
